

Contest Rules

1. Eligibility

HONKY TONK LIMO RAFFLE (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. The Contest is subject to federal, state, and local laws and regulations.

2. Sponsor

5. How to Enter

On-Site: This method of entry will be available at WYNDHAM GARDEN INN, 3401 SOUTH IH 35, AUSTIN, Texas 78741 beginning Thursday February 15th, 2024, thru Sunday, February 18th, 2024. Raffle tickets will also be available at the Ameripolitan Awards Show on Sunday Feb 18th, 2024, at the ACL Live Moody Theater, 310 W 2nd St, Austin, TX 78701 during show hours from 5pm – 10pm.

Online: This method of entry will be available by visiting our website (AMERIPOLITAN.ORG) and following the directions provided to fill out the entry information and submit.

Enter as many times as you wish. There is no limit to the number of entries per person or household. All entries become the property of Sponsor and will not be acknowledged or returned.

6. Prize Drawing

On or about February 19, 2024, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about February 19, 2024. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

7. Winner Notification

The potential winners will be notified by email, mail or phone. Each potential Grand and First Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted or fails to submit the Declaration of Compliance within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize. If the potential winner is at least 18 but still considered a minor in his/her jurisdiction of residence, Sponsor reserves the right to award the prize in the name of his/her parent or legal guardian, who will be required to sign the Declaration of Compliance on the potential winner's behalf and fulfill any other requirements imposed on winner set forth herein. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or

undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

10. Release and Limitations of Liability
